SUBJECT: ISSUANCE OF THE PRE-APPLICATION AUDIT SUMMARY
REPORT FOR THE CLINCH RIVER NUCLEAR SITE

By letter dated February 23, 2022 (ML22055A738), Tennessee Valley Authority (TVA) submitted a request to engage NRC in pre-application interactions in support of development of a construction permit (CP) application for a light-water small modular reactor at TVA's Clinch River Nuclear (CRN) site near Oak Ridge, TN. As the prospective applicant for the CP, TVA began regulatory engagement on the CP application during April 2022.

As part of the pre-application interactions, the staff held an audit November 9, 2022. As stated in the audit plan (ML22285A027), the purpose of the audit was to improve understanding of information for the Clinch River Nuclear (CRN) Site to support the preparation of the applicant's environmental report (ER) and NRC's environmental impact statement (EIS). Enclosed is a summary of the pre-application audit.

After reviewing annotated outlines of TVA's ER, the staff requested that TVA provide an overview of the Programmatic Environmental Impact Statement developed for the CRN site, an overview of the technology selected, potential use of a bounding value approach for ER development, and a discussion of information used to develop the ER outlines.
