By letter dated October 17, 2022, Nuclear Energy Institute (NEI) submitted a guidance document, NEI 22-03, Draft Revision 0, "Nuclear Generation Quality Assurance Program Description," for U.S. Nuclear Regulatory Commission (NRC) review (Agencywide Documents Access and Management System (ADAMS) Accession No. ML22298A229). A clarification call was held on November 28, 2022, to discuss the scope and technical adequacy of the NEI's submittal.
