#### **Certificate of Disposal and Reporting**

Reporting the disposal of your signs to both the USNRC and to the state in which the signs are registered is a regulatory requirement. SRBT is responsible for reporting when new signs are shipped but <u>cannot</u> report the disposal for you. This insures that regardless of who manufactured your signs, regulatory agencies will receive notification from you concerning where signs were sent for disposal at end of life. (See the final page for additional reporting instructions)

SRBT is not required to provide a Certificate of Disposal when signs are returned for disposal and it is not a legal document. A COD is merely a receipt for your records. A COD is not required for reporting the disposal or your signs. A COD will generally not be available until 30-45 days after SRBT receives your signs while your report is due within 30 days of shipping. If you are only looking for a delivery confirmation obtaining that from your chosen carrier is the best alternative and will not add to your cost as a COD does.

SRBT is not required to issue confirmation of either the receipt or disposal of signs returned as ownership of the signs transfers to SRBT upon delivery. Please contact your chosen carrier for proof of delivery. A COD is not automatically issued when signs are returned and never issued based simply on SRBT receiving a shipment. A COD must be requested and paid for (in advance), and the sign check in process completed, prior to a COD being issued.

Please check the box on page 3 of this packet indicating whether or not you are requesting a Certificate of Disposal. Before requesting a COD please note that your regulatory required reporting will likely need to be completed before SRBT is able to issue a COD. COD issue dates are not tied to your reporting requirements nor will one be provided before SRBT has fully processed your return.

#### \*\*\*\*Reporting Proper Disposal of Your Tritium Signs\*\*\*\*

You are required to report to your state regulators and the USNRC that you have properly disposed of your signs. Reporting requires that a simple letter be written stating that you have sent your signs to SRB Technologies, Inc. (NC Radioactive Materials License # 034-0534-2) for proper disposal. Include in the letter the total number of signs returned, the manufacturer(s), serial numbers and the address where they were installed/registered. Include SRBT's name and address as where you sent them and include our license number. You will need to send one copy to your state regulator and one to the USNRC.

If a transportation incident occurs you must report the incident to the USDOT per 49 CFR 171.15 and 171.16. SRBT will also need to be notified. For SRBT contact Brian Pullen at 800-552-0098 extension 202. This is the only part of the disposal process that Brian is involved with so please don't call him for anything other than an incident occurring during transport of the signs back to SRBT. Brain cannot issue RGA numbers, discuss the status or your return, issue COD's or accept payments.

#### **PACKAGING CHECK LIST**

- Have the signs been wiped down removing loose dirt and adhesive?
   If adhesive can't be removed cover it with paper or cardboard.
- 2. Have all brackets, screws and mounting hardware been removed?
- 3. Have double faced signs that aren't enclosed in a single metal housing been separated into individual signs? Contact SRBT if you have questions about, or trouble, separating signs.
- 4. Has an accurate count of the signs, counting double faced as two signs, been performed?
- 5. Has SRBT been notified in writing or with pictures of any damaged signs that may affect pricing and/or packaging requirements? Failing to do say may result in substantial service fees.
- 6. Are the boxes being used of an appropriate size for the size and number of signs being shipped?

  If your boxes would hold 20 or more signs they are too large and may be refused.
- 7. Have your signs been placed in individual boxes, individually wrapped in bubble wrap or other material or been taped together in a bundle?
  - If so they need to be repackaged properly. This is a frequent mistake and is directly addressed in items 7 and 8 in the procedures above. Wrapping or boxing signs individually <u>will</u> result in additional fees. Although you may have ordered replacement signs from SRBT that arrived in individual boxes inside a carton, do not use the individual boxes to repackage the old signs. You may use the large outer carton to package signs and use the individual boxes as filler but do not individually box or otherwise wrap each sign.
- 8. Has an accurate inventory been placed in the corresponding box? Do not attach the Box ID Worksheets to the outside of the box in a packing slip pouch. They come off in transit so please place the inventory only inside the corresponding box.
- 9. Has SRBT been contacted with any questions you have regarding preparation of paperwork or packaging?
  <u>This is the easiest and most assured way to avoid service fees.</u>
- 10. Has all paperwork been completed in its entirety, signed and/or initialed as indicated and returned to SRBT?
- 11. Has the RGA number and the box number been written on the top and at least one side of the carton in a large, legible, easily identifiable print?

The carrier may put stickers on your boxes and cover up your RGA number if it's written in only one area. SRBT is not responsible for shipments refused due to the carrier covering up your RGA number. UPS nor FedEx will wait for us to identify your return if it's not marked properly. Reminder: Box or RGA numbers printed on the shipping label are not policy complaint.
