Good morning Lynette! Hope all is well. I am finishing the review of your amendment request to change the RSO to Dr Peterkin and add Dr Ambrose as an AU.

We are only able to authorize Dr Ambrose for the use of Iodine-131 under 35.300. She won't have the full 35.300 authorization. Do you want us to limit condition 6.C to Iodine-131 use only?

If so, please have management send a signed letter stating that they wish to only utilize I-131 for therapies under 35.300. If not, we will need additional information via a preceptor statement before we can authorize Dr Ambrose for All 35.300.
