This refers to your license amendment request dated September 27, 2022. Please find enclosed Amendment No. 17: (1) authorizing the Troxler Electronic Laboratories (“Troxler”) Model 4640/4640-B; (2) removal of the authorization for the Troxler Model 3216; and (3) adjusting your maximum possession limits.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
