SUBJECT: CROW BUTTE RESOURCES, INC., RESPONSE TO NOTICE OF VIOLATION

AND NRC INSPECTION REPORT 040-08943/2022-001

Dear Mr. Hagman:

On December 15, 2022, the U.S. Nuclear Regulatory Commission (NRC) cited Crow Butte Resources, Inc., for two violations of NRC requirements associated with a failure to submit a license-required report to the NRC in a timely manner and failure to revise or generate a new safety and environmental review panel evaluation to reflect a change in operations in accordance with license requirements.

The NRC Inspection Report 040-08943/2022-001 with enclosed Notice of Violation (Notice) required you to respond in writing within 30 days (Agencywide Documents Access Management System [ADAMS] Accession No. ML22341A205). By letter dated December 29, 2022, you provided a response to the Notice of Violation (ML22363A391).

After reviewing the information provided in your response to Violations 040-08943/2022-01-01 and 2022-01-02, we have concluded that your completed and proposed corrective actions appear to adequately address the regulatory non-compliances identified in the inspection report. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.

The NRC continues to review Unresolved Item 040-08943/2022-01-03 involving your operational method for processing equivalent feed material as compared to the guidance provided in the NRC's Regulatory Issue Summary 2012-06, "NRC Policy Regarding Submittal of Amendments for Processing of Equivalent Feed At Licensed Uranium Recovery Facilities," dated April 16, 2012. The NRC staff will notify you if we need additional information to support our review.
