## Audit Report AUDIT OF THE NRC'S PERMANENT CHANGE OF STATION PROGRAM Status of Recommendations (OIG-22-A-05)

<u>Recommendation 1</u> :	Update agency guidance to fully reflect and comply with federal guidance.
Agency Response <u>Dated January 31, 2023:</u>	The Office of the Chief Financial Officer (OCFO) is in the process of updating Management Directive (MD) 14.2, Relocation Allowances. As part of the update, staff is thoroughly reviewing the relocation process to revise for efficiencies and will ensure that MD 14.2 fully reflects these updates while complying with federal guidance.
	Estimated Completed Date: September 30, 2023, currently under comment review.
OIG Analysis:	The proposed actions meet the intent of the recommendation. The OIG will close the recommendation when the NRC updates agency guidance to fully reflect and comply with federal guidance.
