This letter refers to the decommissioning site inspection conducted on January 19, 2023, with continuing NRC review through February 10, 2023 at your 3M Company, Gamma Sterilizer Facility, Brookings, South Dakota facility (Inspection Report No. 030-14999/2023001). The purpose of the inspection was to support your amendment request to remove the S-8 irradiator from your license. The continuing in-office review was to continue NRC's review of documentation submitted by you to support the license amendment. The enclosed report presents the results of this inspection.

This inspection examined activities conducted under your license as they relate to public health and safety, the common defense and security, and to confirm compliance with the Commission's rules and regulations and with the conditions of your license. Within these areas, the inspection consisted of selected examination of procedures and representative records, observations of activities, and interviews with personnel.
