Dear Ms. Marshall:

Pursuant to 10 CFR 2.390(b), the Nuclear Energy Institute (NEI)¹ requests that the U.S. Nuclear Regulatory Commission (NRC) withhold NEI Technical Report NEI 22-01, "License Termination Process," January 2023, from public disclosure. NEI 22-01 contains confidential commercial information owned by NEI and was provided to the NRC staff as an enclosure to the letter identified below in subparagraph 1.

(1) February 13, 2023, NEI letter to the NRC titled "Request for Review and Endorsement of NEI 22-01, "License Termination Process"

NEI is voluntarily providing NEI 22-01 to the NRC to support improvements in the license termination process for commercial nuclear reactor licensees.

A copy of the affidavit submitted in support of this nondisclosure request is included as Enclosure 1 to this letter. The affidavit sets forth the basis on which the information should be withheld from public disclosure and addresses applicable factors in 10 CFR 2.390(b)(1)(ii)-(iii) and 10 CFR 2.390 (b)(4)(i)-(v). A copy of NEI 22-01 is marked as required by 10 CFR 2.390(b)(1)(i)(A) and is included as Enclosure 2 to this letter. A redacted version of NEI 22-01 is included as Enclosure 3.

If the NRC determines that NEI 22-01 cannot be withheld pursuant to 10 CFR 2.390, then we respectfully withdraw the document and request that it be returned pursuant to 10 CFR 2.390(c)(3).
