APPOINTMENT OF AN ADDITIONAL OFFICE OF NUCLEAR  
MATERIAL SAFETY AND SAFEGUARDS ALTERNATE  
RADIATION SAFETY OFFICER

This memorandum serves as the official notification that Daniel Shaw has been appointed to the Office of Nuclear Material Safety and Safeguards (NMSS) as an additional Alternate Radiation Safety Officer (RSO). Stephen Giebel will remain to concurrently serve as an NMSS Alternate RSO.

The addition to NMSS's RSO staff will improve regional oversight through added expertise and division of labor. This appointment enhances knowledge management among NMSS operations as well as NRC's regional radiation safety program network.

NMSS Policy and Procedures authorizes NMSS Office Director to appoint individuals to serve as the alternate RSO in accordance with NMSS Policy and Procedure 7-01, Rev.1, Section 4, Subpart 1. This memorandum authorizes Mr. Shaw to serve as NMSS alternate RSO and assist the NMSS RSO in duties detailed in Management Directive 10.131, "Protection of NRC Employees Against Ionizing Radiation," and to further serve as acting NMSS RSO when needed.
