Dear Mr. Parker:

As of February 27, 2023, Neal Zhang who is listed on our NRC license as the RSO and an authorized medical physicist is no longer with Parkview Health. Please remove him from our NRC license.

We are currently in the process of retaining a replacement RSO. In the interim period, we are appointing Sharon Updike, MHP, DABR, as the temporary RSO for medical uses permitted by 10 CFR 35.100, 35.200, 35.300, 35.400, and 35.1000 (Y-90 SIRSpheres and Therasphere). She is listed as the RSO on NRC license  $\frac{\#13-02650-02}{13}$ . Qingya (Frank) Zhao, Ph.D will serve as the temporary RSO for medical use 10 CFR 35.600 (Ir-192). Dr. Zhao is listed as an authorized medical physicist on the Parkview Health NRC license  $\frac{\#13-01284-02}{13}$ .

Ms. Updike is an outside consultant with Medical Physics Consultants, Inc. Her position at Medical Physics Consultants allows adequate time and flexibility to address both contractual and regulatory obligations to any facility that she is currently listed as the Radiation Safety Officer. At this time, she performs quarterly audits of our nuclear medicine department. She is available by phone and email to respond to questions or operational issues that arise during the conduct of the radiation safety program and related regulatory requirements. If a situation arises where she cannot answer her phone and the facility needs an immediate response, they are instructed to call Medical Physics Consultants main office for assistance. If a situation occurs after office hours, MPC has an answering service that operates 24 hours a day, 7 days a week, 365 days a year. The amount of time for the RSO to physically arrive at the facility in response to an emergency involving radioactive material will vary depending upon her activities that day. A conservative estimate of the amount of time required for Ms. Updike to arrive at the facility is approximately 3 hours. A response by phone would be immediate.
