Dear Tahir Mohamed:

This refers to the amendment request letter dated October 20, 2022, and March 3, 2023, received in our offices on March 7, 2023. Your letter requests changing the Radiation Safety Officer (RSO) on your license to Mufeed Otaibey, M.S.

Since your letter failed to include sufficient information needed to complete this review, I called the only phone number stated in the letter, 313-945-9000. I called this number, told the person answering the call who I was, the name of my agency and my position, who I needed to speak to and why. She referred me to "Pam." I told Pam the exact same specific information. She referred me to Aida Berry. I told Aida the exact same specific information also. She gave me your cellphone number and email address.

Please specify the date when Ray Carlson ceased to serve as your RSO.

We do not know who Mufeed Otaibey, M.S. is or what his/her qualifications and credentials are that would make him/her acceptable as your new RSO, among other things. Please provide the appropriate qualifications for Mufeed Otaibey, M.S. and please do not submit college transcripts, patient records, resumes or curricula vitae.

Please be sure to include in your response a currently dated and signed Delegation of Authority (DoA), a sample of which is

found in Appendix I. Both Mufeed Otaibey, M.S. and a senior management representative for this license must sign the DoA.

Address your written response to my attention and identify it as additional information to control no. 634745. It must be accompanied by either an NRC Form 313 or a letter containing all the information on the NRC Form 313, in addition to the specific information about Mufeed Otaibey. Only submit **one** complete response by **one** means of transmission, sending a scanned PDF attached to an email works fine. That should be sent to R2-DRSSMail.Resource@nrc.gov with a "cc" to me. My fax number is 630-515-1078. The street address is in our header above.

Please provide this information within 30 days, or by **close of business April 14, 2023.**
