Discussion: Mr. vonEhr called both Mr. Parkins and, separately, Mr. Neal to discuss the change of RSO Amendment Request (MC 634615), and described the need to describe Mr. Neal's experience with portable nuclear gauges i.a.w. NUREG-1556, Vol. 1, Rev. 2, Section 8.7, which was not provided in the initial request.

Action: Mr. Neal committed to providing a written and signed response within 2 days and, as a result, Mr. vonEhr opted using this telephone record and the attached email as the RAI rather than a typical letter format.

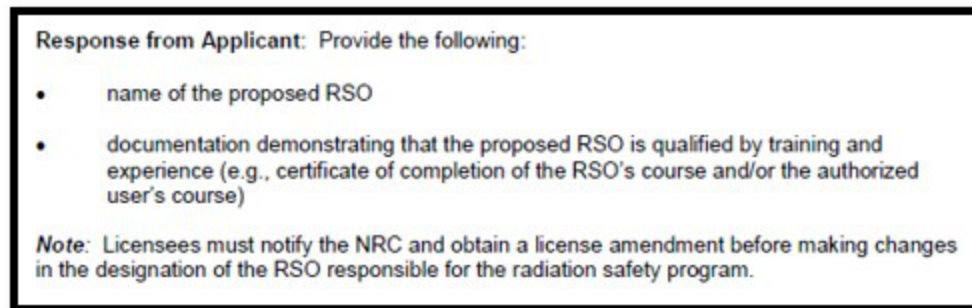

Lane (& Jamelle, who called me back while I was talking with Lane),

As discussed over the phone, the NRC is in receipt of your request to amend the license. Per the NRC's guidance document for portable nuclear gauges: NUREG-1566, Volume 1, Revision 2 (<https://www.nrc.gov/reading-rm/doc-collections/nuregs/staff/sr1556/v1/index.html>), Section 8.7 "Individual(s) Responsible for Radiation Safety Program and Their Training and Experience," an amendment to the license for a new RSO must demonstrate adequate training *and experience*. The request by Triton adequately captures Mr. Neal's training, but did not include a description of his experience with portable nuclear gauges.



Lane stated that he could crack out a quick letter supplementing the initial submission with this information; your timely action is appreciated, and saves me bit of work. As discussed, this letter must be signed by an appropriate mgmt. representative (you can email it to me for more timely action, vs mailing a hard copy). For everyone's education, the 'who signs the letter' bit is also from NUREG-1556, and is covered in Section 8.13 "Certification." If you have any questions or concerns, please do not hesitate to reach out to me.

P.S. your initial letter quoted the incorrect license number ("46-31438-01") – off by a digit. The correct license is "47-31438-01."
