Dear Ms. Clark:

Enclosed is a copy of proposed legally binding requirements to address changes to rulemaking due for State adoption. We are proposing two license conditions. License Condition 1 addresses gaps from RATS-IDs 2019-1 through 2021-2 as compared to Wisconsin regulations currently in force. This license condition is being prepared to address timeliness issues related to RATS-ID 2020-1 and will only be used until the proposed rule package currently waiting with our legislature becomes final. NRC previously reviewed comments on this proposed rule package in 2022.

License Condition 2 addresses regulatory changes in RATS-ID 2021-2. RATS-ID 2021-2 was not included in our previous (2022) rule package. Therefore License Condition 2 fulfills legally binding requirements for RATS-ID 2021-2.

The legally binding requirements correspond to the following equivalent amendments to NRC's regulations:

Proposed License Condition 1:

In lieu of s. DHS 157.44(6); s. DHS 157.45(11)(c); s. DHS 157.53(3)(a); s. DHS 157.71(4)(b)3.; s. DHS 157.72(2)(f)1.b.; s. DHS 157.73(14)(a); s. DHS 157.94(6)(c); s. DHS 157.9703(3); ch. DHS 157 Appendix O, Determination Of A₁ And A₂; and ch. DHS 157 Appendix U, Category 1 and Category 2 Quantity of Radioactive Material Thresholds, the licensee shall comply with Title 10, Code of Federal Regulations as it exists on March 23, 2023:

- (a) Part 34 sections 34.47, 34.83(c); and
- (b) Part 35 section 35.3045(g)(1)(ii), 35.3047(g)(1)(ii); and
- (c) Part 36 section 36.55(a); and
- (d) Part 37 sections 37.27(c), Appendix A, Category 1 and Category 2 Radioactive Materials; and
- (e) Part 39 section 39.65(a); and
- (f) Part 71 section 71.101(c)(1), and Appendix A, Determination of A₁ and A₂.

Except as follows:

- (a) Any reference to the Commission or NRC shall be deemed to be a reference to the Wisconsin Department of Health Services, except:
 - a. References to the NRC Web site; and
 - b. References to U.S. Nuclear Regulatory Commission as part of a mailing address.
- (b) Licensee request for approval of package quality assurance program in 71.101(c)(1) shall be submitted to DHS using the contact information in DHS 157.13(17).

Proposed License Condition 2:

In lieu of ch. DHS 157, Appendix U, Category 1 and Category 2 Quantity of Radioactive Material Thresholds, the licensee shall comply with Title 10, Code of Federal Regulations, Part 37 Appendix A, Category 1 and Category 2 Radioactive Materials, as it exists on March 23, 2023.
