Enclosed is Amendment No. 26 renewing TestAmerica Laboratories, Inc.'s (your) U.S. Nuclear Regulatory Commission (NRC) Materials License No. 24-24817-01 in accordance with your November 3, 2022 renewal application. Your renewal application is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML22308A019. The NRC's ADAMS, accessible from the NRC Web site at <https://www.nrc.gov/reading-rm/adams.html>.

Please review the enclosed document carefully, and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III Office at 630-829-9892 so that we may provide appropriate corrections and answers.

As discussed via phone on April 28, 2023, and confirmed via your letter submitted on April 28, 2023, we have updated your license to reflect the scope of radioactive materials currently authorized and used. In accordance with your confirmation that nickel-63 and barium-133 sealed sources are no longer needed, under the license, those authorizations have been removed. License conditions associated with authorizations for sealed sources have been removed or updated, accordingly.

An environmental assessment for this action is not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (10 CFR) Section 51.22(c).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance that NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's expectations for individuals and organizations to establish and maintain a positive safety culture.
