SUBJECT: SUMMARY OF MAY 16, 2023, TELEPHONE CALL WITH CENTRUS-AMERICAN CENTRIFUGE OPERATING. LLC. REGARDING A SECURITY FEATURE FOR THE AMERICAN CENTRIFUGE PLANT

On May 16, 2023, the U.S. Nuclear Regulatory Commission staff participated in a telephone conference call with staff from American Centrifuge Operating, a subsidiary of Centrus Energy Corp., to discuss whether a certain security feature will be needed for future operations planned for the American Centrifuge Plant in Piketon, Ohio.
