SUBJECT: TIMKIN MOTOR & CRANE SERVICES, LLC, REQUEST FOR ADDITIONAL

INFORMATION, MAIL CONTROL NO. 629074

Dear Mr. Rapp:

This is in reference to the financial assurance (FA) requirement for your NRC license. This licensing action is intended to remove all references to the Gando Drive address from all financial assurance documents; return the funds that provided FA for the Gando Drive address from the current Trust Agreement; and for the Commerce Drive address, to convert the current Trust Agreement to a Standby Trust which is funded by a Surety Bond, with all updated FA documents to support the Standby Trust. This letter is refers to your letter dated October 25, 2021 and April 5, 2023, with attached documents. This also refers to various email correspondence between members of your staff and me, during the period of February and May 2023; in particular email from the NRC dated February 17 and 28, 2023, and March 27; and Timken email dated January 13, 2022, March 9, 2023 and May 18, 2023.

In order to continue our review, we need the following additional information:

- At this time, the NRC holds the Trust Agreement dated April 27, 2016 (ML16196A233) with Schedules A, B and C referring to Gando Drive and the previous amount of FA; specimen Certificate of Events; specimen Certificate of Resolution; and Letter of Acknowledgement.
 - a. Confirm if the Trust Agreement has been amended in any way with the change from funded Trust Agreement to a Standby Trust supported by a Surety Bond. If so, the NRC requires an originally signed duplicate of the amended Trust Agreement.
 - b. Provide an originally signed duplicate of the updated Schedules A, B, and C that were attached to an email dated May 4, 2023, between your staff members.
- 2. At this time, the NRC holds a Certification of Financial Assurance (CFA) dated July 24, 2017 (ML17278A347) which refers only to the Gando Drive location. Although an updated CFA was requested in the February 17 email, this item was not mentioned in the many discussions of the revisions needed for the Trust Agreement to be amended to a Standby Trust. Provide an updated CFA that refers only to the Commerce Drive location and the amount of FA provided by the Surety Bond for that location.

3. At this time, the most recent Decommissioning Funding Plan (DFP) and cost estimate for the Commerce Street address is dated August 2021, and was provided with your letter dated October 25, 2021. As you are aware, the DFP is required to be updated every three years, so the next revision should be August 2024. No action is required at this time.

We will continue our review upon receipt of this information. In this case, because the Schedules do not require a signature, the document may be provided by electronic mail sent directly to me at Elizabeth.Ullrich@nrc.gov, referencing Mail Control No. 629074.

While it is allowable, please refrain from submitting proprietary information in support of a license unless necessary. Keep in mind that all NRC licenses are considered to be in the public domain, and therefore may be viewed by any member of the public who requests to see them.
