This refers to your license amendment request dated January 30, 2023. Please find enclosed Amendment No. 43 authorizing David Blonder, M.D. and Dr. Mrinal Mali, M.D. on license number 06-10957-01 for 10 CFR 35.100 and 35.200 uses. Regarding your request to add Michael T. O'Loughlin, M.D. for 10 CFR 35.100 and 35.200 uses, this individual was previously authorized on Amendment No. 42 for the requested uses. This individual's authorization was retained for Amendment No. 43.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
