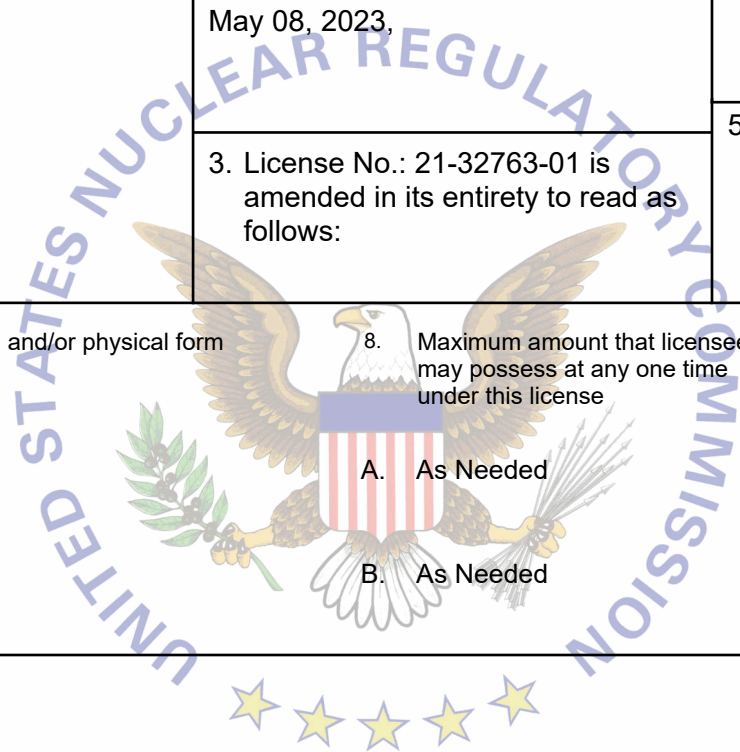


MATERIALS LICENSE

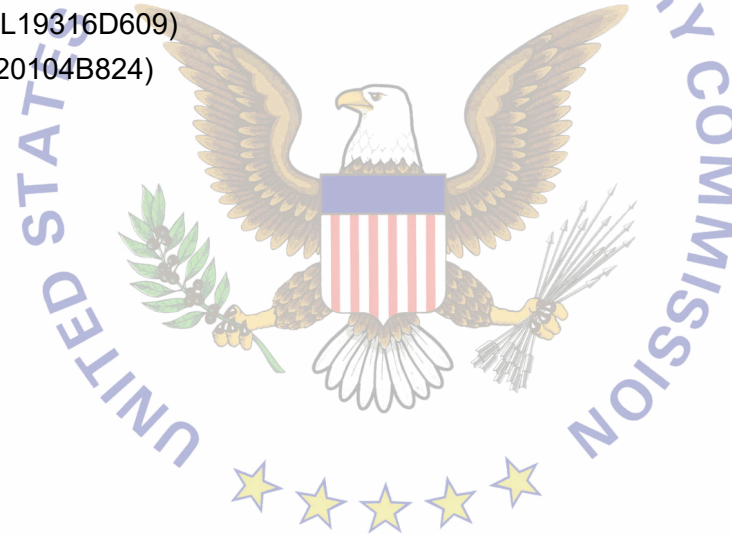
