On June 21, 2023, representatives of BWXT met with NRC personnel in the NRC Region 2 office located in Atlanta, GA, to discuss two apparent violations identified in NRC Inspection Report No. 07000027/2023-006; (NRC's Agencywide Documents Access and Management System (ADAMS) Accession No. ML23115A020). The conference was held at the request of the licensee and was conducted in-person with some participants and members of the public attending virtually via Microsoft Teams.

The licensee presented a summary of the causes for the apparent violations and their corrective actions. A copy of the presentation slides is publicly available in ADAMS Accession No. ML23177A005.
