Dear Joseph M. Stocking:

Enclosed is Amendment No. 14 to your U.S. Nuclear Regulatory Commission (NRC) Materials License No. 21-26634-01 in accordance with your request dated May 1, 2023. Specifically, you requested to delete the location of use located at 2949 Jolly Road, Okemos, Michigan from the license. Your request is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML23121A150 (non-public).

The NRC staff has reviewed the information you provided, including the sealed source leak tests. Based on its review, the NRC staff has concluded that all licensable radioactive material has been removed from your facility located at 2949 Jolly Road, Okemos, Michigan, and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions, no further remediation or actions are required with respect to NRC-regulated material at 2949 Jolly Road, Okemos, Michigan. Therefore, your facilities located at 2949 Jolly Road, Okemos, Michigan are suitable for unrestricted use. Please note that, based on a change in the number of locations of use authorized in the license, the program code for your license is changed to 03121 (one to five locations of use). For your reference, the program code descriptions are listed on the NRC's website at: <https://www.nrc.gov/materials/miau/mat-toolkits.html>.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III office at (630) 829-9887 so that we may provide appropriate corrections and answers.

An environmental assessment for this action is not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (CFR) Section 51.22(c).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with
