Dear Tim Knowles:

The U.S. Nuclear Regulatory Commission (NRC) staff has received your letter dated May 15, 2023, transmitting Revision 026 to the Nuclear Fuel Services, Inc. Site Security Physical Protection Plan. The cover letter is available in the NRC's Agencywide Documents Access and Management System (ADAMS) under Accession Number ML23146A186.

We have completed our acceptance review of your submittal and have identified no administrative omissions or deficiencies that would prevent us from proceeding with a detailed review. Your request has been assigned Enterprise Project Identifier (EPID) L-2023-SPR-0002. Please reference that EPID number and Docket Number 70-143 in any future correspondence associated with this request.

Please note that the NRC staff's technical review of your submittal may identify issues that require additional information. Based on our preliminary review and projection of current review schedules, we anticipate completing our review by December 1, 2023. This date could change depending on the findings of our technical review, urgent assignments, or other factors. We will promptly communicate any significant changes to this schedule. In addition, the NRC staff estimates that completing the review of your submittal will require up to 80 staff hours, which corresponds to about \$23,200.00 (\$290.00/hr.)

In accordance with Title 10 of the *Code of Federal Regulations*, Section 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available for public inspection in the NRC Public Document Room (PDR) or electronically from the Publicly Available Records System component of ADAMS. The PDR is currently open Monday-Friday by appointment only.
