Dear Dr. Hatcher:

This refers to your license amendment request dated February 2, 2023. Please find enclosed Amendment No. 56 which includes the letter informing us of change in the identification designation of the new waste facility. Based on an email discussion dated April 5, the existing waste facility is not being decommissioned and a new location identified, but the current location was given a new building number. As a result, the license is amended without any further decommissioning review.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
