Good afternoon, James:

I have two quick clarification questions regarding the referenced amendment request, for which NRC's review is ongoing.

- Is the Ste. information needed to be listed on the license in Condition No. 10 (location of use). Or is the address as currently listed adequate to meet PharmaLogic's (your) needs?
- 2. Is the only substantive change to the license the increased Ge-68/Ga-68 possession limits? For example, has the generator breakthrough testing policy been updated from information previously submitted to NRC?

Please note that this review is limited to the possession limit increase only. The updated decommissioning funding plan (DFP), decommissioning cost estimate (DCE), Financial Assurance certification, and Standby Trust Agreement are being reviewed separately. NRC will need a financial assurance instrument (surety bond, letter of credit, etc.) in-house prior to accepting DFP/DCE, STA, and certification. We will be in touch soon regarding that review.
