Enclosed is Amendment No. 43 to your NRC Materials License No. 21-16560-01 in accordance with your April 26, 2023 request. This request was to remove two field locations from the license. Your application is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML23117A173.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (10 CFR) 51.22(c).

The NRC staff has reviewed the information provided. Based on its review, the NRC staff has concluded that all licensable radioactive material has been removed from your field stations located at 322 N. Main Street, Standish, Michigan 48658, and 3530 East 18th Street, Casper, Wyoming, 82609, and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions, no further remediation or actions are required with respect to NRC-related material. The above locations are suitable for unrestricted use.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary
