This refers to your license amendment request dated March 27, 2023. Please find enclosed Amendment No. 59 authorizing the removal of two locations of use from your NRC license. The facilities located at 3701 MacCorkle Ave SE, Charleston, West Virginia, and 2345 Chesterfield Avenue, Suite 302, Charleston, West Virginia, are deemed suitable for release for unrestricted use. Please note as a result of the removal of these two facilities, License Condition 15 has been revised to remove the references to items 15.C, H, and J, regarding letters dated October 31, 2017, August 23, 2021, and July 22, 2022, respectively, and has been re-ordered as a result.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(20).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
