This refers to your license amendment request dated March 17, 2023. Please find enclosed Amendment No. 2 which removed your authorized location near Teas Valley, WV, authorized a field location at 100 Federal Drive, Welch, WV, and granted an extension of your license expiration date to August 31, 2028.

An environmental assessment for this action was not required since this action is categorically excluded under 10 CFR 51.22(c)(14).
