REVISION OF THE CHRONOLOGY OF THE U.S. NUCLEAR REGULATORY COMMISSION (NRC) AMENDMENTS INCLUDING SUMMARY OF CHANGE DOCUMENT FOR MISCELLANEOUS CORRECTIONS, 10 CFR PARTS 1, 2, 26, 32, 40, 50, 51, 52, 72, and 73 [RATS ID 2023-1] (STC-23-064)

Purpose: To provide the Agreement States with the Chronology of the U.S. Nuclear Regulatory Commission (NRC) Amendments including RATS ID 2023-1.

Background: The NRC is amending its regulations to make miscellaneous corrections. These changes include updating organizational information, revising an address, and correcting reference, spelling, and grammatical errors.

Discussion: The final rule, published on August 24, 2023, is posted in the *Federal Register* (FR), ([88 FR 57873](#)). The Chronology of NRC Amendments, including RATS ID 2023-1, as maintained by the Office of Nuclear Material Safety and Safeguards (NMSS) can be found on the NMSS website at: <https://www.nrc.gov/materials/toolboxes/regulation.html>. The chronology is for your use to plan rulemaking actions that are needed to satisfy the compatibility and health and safety category designations of the NRC regulations. This document will also be used by the Integrated Materials Performance Evaluation Program (IMPEP) teams during upcoming program reviews.

The Standing Committee on Compatibility reviewed the rule and determined that the provisions in 10 CFR Parts 32 and 40 of this rulemaking are a matter of compatibility with the Agreement States. Since these regulations are designated as a 'B' compatibility category (for §32.72(a)(2)(i)) and 'C' compatibility category (for Appendix A to 10 CFR part 40), the Committee determined that the Agreement States have to adopt these provisions for compatibility purposes, and they need to submit them for a compatibility review.
