This refers to your license amendment request dated May 12, 2023. Please find enclosed Amendment No. 42 authorizing the use of PET radioisotopes at your Newark, Delaware, facility, consistent with your revised letter dated June 18, 2023, and the associated revised shielding calculations provided by a third-party health physics organization.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
