This letter documents the U.S. Nuclear Regulatory Commission (NRC) staff's plan to perform an inspection of Thermo Fisher Scientific's Appendix B, "Quality Assurance Program Criteria for Nuclear Power Plants and Fuel Reprocessing Plants," to Title 10 of the Code of Federal Regulations (10 CFR) Part 50, "Domestic Licensing of Production and Utilization Facilities," and 10 CFR Part 21, "Reporting of Defects and Noncompliance," programs as they pertain to activities conducted at your facility related to the manufacturing of replacement parts and calibration and repair services for NRC's regulated facilities.

As discussed via teleconference on September 6, 2023, the NRC inspection team plans to arrive at your facility on Monday, October 16, 2023, and will conduct an inspection through Friday, October 20, 2023. Subsequent to the inspection, a report will be issued and transmitted to you via letter.
