This refers to the license amendment request dated June 26, 2023, submitted by Randy Damron, your Director of Diagnostic Imaging and Cardiology. Please find enclosed Amendment No. 80 adding Kushal Y. Mehta, M.D. as an authorized user for 10 CFR 35.100 and 35.200 materials and removing Kenedy Foryoung, M.D. Please consider the addition of another authorized user to support the one remaining authorized user listed on your license in a future amendment request.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
