SUBJECT: NOTIFICATION OF WEST VIRGINIA'S REQUEST FOR AN AGREEMENT
UNDER SECTION 274 OF THE ATOMIC ENERGY ACT OF 1954, AS
AMENDED AND OFFERING TRIBAL CONSULTATION

Dear President Dotson:

The purpose of this letter is to notify and to offer consultation to the Delaware Nation, Oklahoma with the U.S. Nuclear Regulatory Commission (NRC) concerning West Virginia's request for an agreement under Section 274 of the Atomic Energy Act, of 1954, as amended in accordance with the NRC's Tribal Policy Statement.¹ The State of West Virginia submitted a letter of intent on January 9, 2023,² to notify the NRC that it is interested in pursuing an Agreement with the NRC to assume regulatory authority over specified radioactive materials and activities.

The NRC offers to consult with the Delaware Nation, Oklahoma in accordance with the NRC's Tribal Policy Statement because the proposed Agreement could have a substantial direct effect on the Tribe by changing the relationship between the NRC and the Tribe since the National Environmental Policy Act and National Historic Preservation Act's Tribal consultation provisions do not apply to Agreement State licensing actions. The NRC's Tribal liaisons (TLs) will serve as the primary points of contact during this process, along with the NRC Project Manager for the West Virginia Agreement. The NRC will be offering consultation to all the Tribes on the enclosed list.
