On May 20, 2021, TranSystems Corporation (TranSystems) purchased all of the outstanding stock in CDI Infrastructure Holdings, Inc., a Delaware corporation (CDI Holdings). The purchase included all of the subsidiary companies owned by CDI Holdings, including CDI Infrastructure Inc., d/b/a L.R. Kimball, which is now a wholly owned subsidiary of TranSystems Corporation. Attached for reference is the Stock Power and Assignment, evidencing the transfer of the shares from CDI Holdings to TranSystems and the change of ownership.

STOCK POWER AND ASSIGNMENT

FOR VALUE RECEIVED, pursuant to that certain Securities Purchase Agreement, dated as of the date hereof, by and among **TRANSYSTEMS CORPORATION**, a Missouri corporation ("*Assignee*"), **CDI INFRASTRUCTURE HOLDINGS, INC.** a Delaware corporation, and **CDI HOLDING COMPANY, LLC**, a Delaware limited liability company (the "*Stockholder*"), the Stockholder hereby (i) sells, assigns, and transfers to TransSystems Corporation, free and clear of all liens, mortgages, pledges, adverse claims, charges, security interests, encumbrances or other restrictions or limitations whatsoever, all of the Stockholder's right, title and interest in and to a total of 100 shares of Common Stock of **CDI INFRASTRUCTURE HOLDINGS, INC.**, a Delaware corporation (the "*Company*"), par value \$0.01 (the "*Shares*"), standing in the name of the Stockholder on the books of the Company represented by stock certificate No. 2 to be delivered herewith, and (ii) irrevocably constitutes and appoints the Secretary of the Company as attorney-in-fact to transfer the Shares on the books of the Company with full power of substitution in the premises. The Stockholder (A) hereby represents and warrants to the Company that the Stockholder has not pledged, assigned, hypothecated, or otherwise encumbered the Shares in any way and is the sole and exclusive owner of the Shares, and (B) binds the Stockholder's successors and assigns to forever warrant and defend title to the Shares unto Assignee against any person claiming the same, or any part thereof.
