## Dear Ralph O. Meyer:

By letter dated August 1, 2022 (Agencywide Documents Access and Management System Accession No. ML22284A087), you submitted a petition for rulemaking requesting that the NRC revise the acceptance criteria for emergency core cooling system performance in Section 50.46 of Title 10 of the *Code of Federal Regulations*. The purpose of this email is to provide an update on the status of your petition and inform you that there is a public meeting scheduled for October 25, 2023, that may be of interest to you.

On November 23, 2022 (87 FR 71531), the NRC published in the *Federal Register* a notice of acceptance and docketing of PRM-50-124 and requested comments on the petition. The comment period closed on March 8, 2023, and the NRC received several comment submissions, which can be found at <a href="https://www.regulations.gov">https://www.regulations.gov</a> under Docket ID NRC-2022-0178. The NRC is evaluating your petition and the associated public comments. Once the NRC makes a determination on the petition, the NRC will notify you and publish a notice in the *Federal Register* explaining the Commission's decision.

On October 25, 2023, the NRC staff will hold a public meeting to discuss the regulatory basis (ML23032A504) for a rulemaking on "Increased Enrichment of Conventional and Accident Tolerant Fuel Designs for Light-Water Reactors." The regulatory basis for this rulemaking addresses, in part, issues regarding fuel fragmentation, relocation, and dispersal relevant to fuels of higher enrichment and burnup levels. A copy of the meeting notice is attached.
