A close out of all radioactive use areas was performed.

Wipe tests were analyzed with a Caprac t Well Counter, serial number 010827. The efficiency factor is 1.23 dpm/cpm and the MDA is 38 dpm. The action level for wipe test results was 1000 dpm/100 cm².

Surveys were performed using a Ludlum 14C survey meter, serial number 155491. The meter was last calibrated on November 10, 2022. The range used was 0-0.2 mR/hr and the action level for exposure rate surveys was 0.1 mR/hr.

Visual Check

The room was checked to verify no radioactive materials remained. Only Tc-99m radiopharmaceuticals were used at this address. The last date of receipt of radiopharmaceuticals was June 22, 2023. All sealed sources were transferred to our office at 3210 Eagle Run Drive, N.E., Grand Rapids, MI 49525. There is no history of any leaking sources. The most recent sealed source leak test is enclosed.

Radiation Level Survey

No area demonstrated radiation levels in excess of the background reading of <u>0.02</u> <u>mR/hr.</u>
