This correspondence refers to your license amendment request dated September 19, 2023. Please find enclosed Amendment No. 1 to your U.S. Nuclear Regulatory Commission (NRC) License No. 24-35692-01 in accordance with your request.

An environmental assessment for this action was not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (CFR) 51.22(c).

In your letter dated October 16, 2023, you confirmed that radioactive material has never been used in room 300.83 located at 1520 Wentzville Parkway, Wentzville, Missouri 63385. Based on the information provided, NRC staff concluded that residual radioactive material does not exceed current NRC criteria in 10 CFR Part 20, Subpart E. Therefore, room 300.83 is suitable for unrestricted use.

You will be periodically inspected by the NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action(s) against you. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking your license as specified in the NRC Enforcement Policy.
