| SUBJECT: | U.S. NUCLEAR REGULATORY COMMISSION SUMMARY OF THE OCTOBER 25, 2023, PREAPPLICATION PUBLIC MEETING WITH SMR, LLC (A HOLTEC INTERNATIONAL COMPANY) TO DISCUSS THE SMR-160+ RISK SIGNIFICANCE METHODOLOGY |

The U.S. Nuclear Regulatory Commission (NRC) held an observation public meeting on October 25, 2023, with SMR, LLC (SMR), a Holtec International Company (Holtec), to discuss the SMR-160+ Risk Significance Methodology (RSM).¹ SMR (Holtec) provided presentation slides to support the discussion during the public meeting.² This meeting summary satisfies the SMR (Holtec)'s request for review and feedback on its preapplication meeting materials.

This virtual observation preapplication meeting had attendees from SMR (Holtec) and NRC staff. There were no members of the public observing the meeting. There was no need to hold a closed session to discuss proprietary information.
