Dear RSO Sutyak:

Enclosed is Amendment No. 9 renewing your NRC Materials License No. 24-32434-01 in accordance with your May 15, 2023 renewal application. In addition to being renewed, Authorized Users were both added and removed, and a location of use has been removed. Your application is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML23163A019.

In letter dated May 15, 2023, you contacted the U.S. Nuclear Regulatory Commission and indicated that you permanently ceased principal activity at your 2002 Kanell Blvd. location and wished to remove the location from your license. The NRC staff has reviewed all submitted information. Based on its review, the staff has concluded that all licensable radioactive material has been removed from your facility and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions, no further remediation or actions with respect to NRC regulated material is required. Your facility at 2002 Kanell Blvd. #201, Poplar Bluff, Missouri, is suitable for unrestricted use.

Your license was amended to reflect current standard NRC policy. It has had several conditions updated to reflect the NRC's current standards and formatting. Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (10 CFR) 51.22(c).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous

enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
