On June 1, 2023, General Electric Company (GE), GE-Hitachi Nuclear Energy Americas, LLC (GEHA) and Global Nuclear Fuel-Americas, LLC (GNF-A) (together, "Applicants") submitted an Application for Order Consenting to Indirect Transfer of Control with Respect to Reactor Licenses, Materials Licenses

and Export Licenses, and Notification Regarding Other Approvals ("Application") (Reference 1). The NRC accepted the Application for technical review on July 27, 2023 (Reference 2). On August 17, 2023, Applicants supplemented the Application by submitting responses to each of the NRC Staff's observations that were enclosed with the NRC's acceptance letter (Reference 3). On September 27, 2023, Applicants further supplemented the Application by providing information on the principal officers of GE Vernova Corp. (Reference 4). On November 30.2023 NRC issued order EA-23-132 approving the indirect transfers of control of licenses (Reference 5)

The purpose of this letter is to provide additional information to the Application. Specifically, in the Application, Applicants stated that they would provide the names of the board members for GE Vernova Corp. when those individuals are identified. Attached is a Revised Exhibit D, which lists the board members for GE Vernova Corp.
