SUMMARY:

On November 30, 2023, the NRC staff held a Microsoft Teams virtual public information meeting with a question and answer session regarding activities and licensing actions associated with the Homestake Mining Company of California (HMC), Grants Reclamation Project (GRP). The meeting was noticed on November 6, 2023, on the NRC website and can be found at NRC's Agencywide Documents Access and Management System (ADAMS) (Accession No. <u>ML23310A049</u>). The purpose of this meeting was for the NRC staff to meet directly with individuals to discuss regulatory and technical issues related to the GRP. Attendees had an opportunity to ask questions of the NRC staff or make comments about the issues discussed throughout the meeting; however, the NRC did not actively solicit comments toward regulatory decisions at this meeting.
