TRAINING: No special training is required for any documents issued with this Change Notice.

REMARKS: IP 71130.01, "Access Authorization." This document was revised to incorporate language clarification in section 02.03c and guidance language in 02.09. This revision also meets the 5-year periodic review requirement.

OpESS 2010/02, "Sample Selections for Reviewing Licensed Operator Examinations and Training Conducted on the Plant-Referenced Simulator" (ML102250302, ML102250307). Deleted for the following reasons: The content in this OpESS is out-of-date and discussion is geared more towards licensees instead of inspectors. Additionally, no similar trend has been seen with regards to licensed operator training. This OpESS has been reviewed for items that should potentially be incorporated in the associated IP and will be added in the upcoming IP revision by the Operator Licensing and Human Factors branch (IOLB).

IP 87121, "Industrial Radiography Programs." Revised in its entirety. Specific changes include: (1) divided inspection guidance into risk-modules; (2) included inspectors' observations; (3) updated inspection guidance; (4) added an estimated level of effort to complete an inspection; and (5) developed new appendix titled "Additional inspection elements."

IP 87122, "10 CFR Part 36 Panoramic Dry-Source-Storage, Panoramic Wet-Source-Storage, and Underwater Irradiator Programs." Revised in its entirety. Specific changes include: (1) divided inspection guidance into risk-modules; (2) included inspectors' observations; (3) updated inspection guidance; (4) added an estimated level of effort to complete an inspection; and (5) developed new appendix titled "Additional inspection elements."

IP 87122, "10 CFR Part 36 Panoramic Dry-Source-Storage, Panoramic Wet-Source-Storage, and Underwater Irradiator Programs." Revised in its entirety. Deleted due to the following reasons: 1) No longer referenced in any current IMC; 2) No time has been charged to this IP since 10/2017; 3) All elements in IP 83100 are covered in detail in current IPs; and 4) Regional branch chiefs had no objection to the deletion of this IP.
