EVALUATION

By letter dated December 14, 2023, (Agencywide Documents Access and Management System Accession No. ML23348A180), Framatome Inc. requested a five-year renewal of certificate of compliance (CoC) No. 9248, for the Model Nos. SP-1, SP-2, and SP-3 transportation packages. No other changes were requested.

The certificate has been updated to Revision No. 27.

CONDITIONS

The following changes have been made to the CoC:

Condition No. 14 was revised to extend the validity of Revision No. 26 of the certificate to April 30, 2024.

Condition No. 15 was updated to reflect the new expiration date of Revision No. 27 of the certificate of April 30, 2029.

CONCLUSION

Based on the statements and representations in the renewal request, the staff finds that these changes do not affect the ability of the package to meet the requirements of Title 10 of the *Code of Federal Regulations* Part 71.
