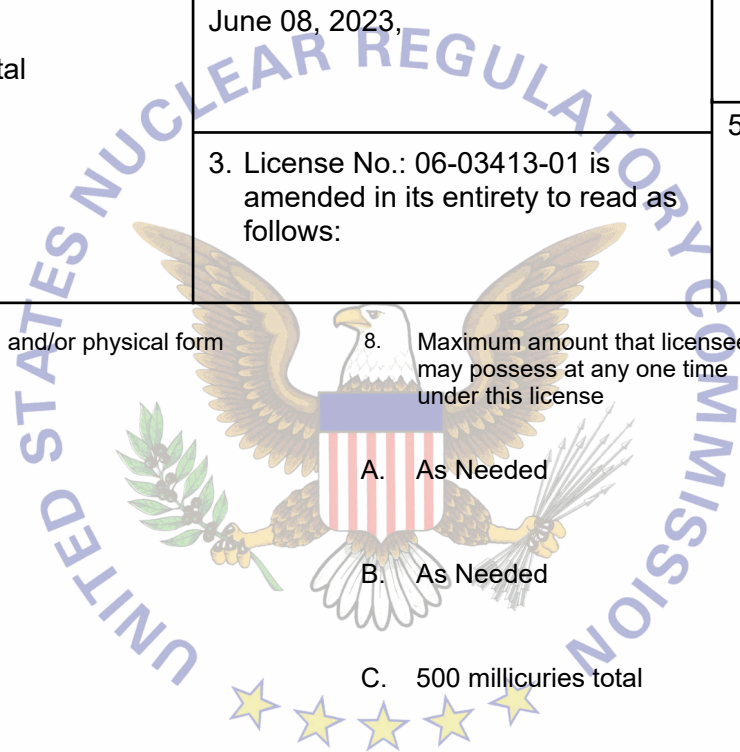


MATERIALS LICENSE

Pursuant to the Atomic Energy Act of 1954, as amended, the Energy Reorganization Act of 1974 (Public Law 93-438), and Title 10, Code of Federal Regulations, Chapter I, Parts 30, 31, 32, 33, 34, 35, 36, 37, 39, 40, 70 and 71, and in reliance on statements and representations heretofore made by the licensee, a license is hereby issued authorizing the licensee to receive, acquire, possess, and transfer byproduct, source, and special nuclear material designated below; to use such material for the purpose(s) and at the place(s) designated below; to deliver or transfer such material to persons authorized to receive it in accordance with the regulations of the applicable Part(s). This license shall be deemed to contain the conditions specified in Section 183 of the Atomic Energy Act of 1954, as amended, and is subject to all applicable rules, regulations, and orders of the Nuclear Regulatory Commission now or hereafter in effect and to any conditions specified below.

C. For the Authorized Users under LC 12.B. with a Bachelor of Medicine, Bachelor of Surgery (MBBS) – the MBBS is acceptable because the NRC is granting an exemption, under 10 CFR 35.19, to include these individuals as AUs under 10 CFR 35.2. In this instance, these physicians have obtained state licensure as medical doctors. Allowing their ability to be authorized users on this license is authorized by law, will not endanger life or property or the common defense and security and is otherwise in the public interest given the equivalency of their professional training and degree to that of a “medical doctor” or “doctor of osteopathy.”

13. In addition to the possession limits in Item 8, the licensee shall further restrict the possession of licensed material to quantities below the minimum limit in 10 CFR 30.35(d) for which decommissioning financial assurance is required.
