Dear Daniel H. Blossfeld:

The U.S. Nuclear Regulatory Commission (NRC) issued a Radioactive Materials License No. 21-00016-04 for General Motors LLC as authorized under Title 10 of the *Code of Federal Regulations* (CFR) part 30. Based on your request to terminate the license in the application dated June 28, 2023 (NRC's document system, Agencywide Documents Access and Management System (ADAMS) at Accession No. ML23227A107), the NRC staff has terminated the license under Mail Control No. 636801. As a result, we have cancelled and are returning the previously approved financial mechanism, Letter of Credit (LOC) No. S115266 dated February 7, 1991 (ML24008A063), Amendment 1 to LOC dated February 11, 1992 (ML24008A068), Amendment 2 to LOC dated January 28, 1993 (ML24008A071), Amendment 3 to LOC dated August 29, 1994 (ML24008A075), and Standby Trust Agreement dated February 7, 1991 (ML24008A078).

An environmental assessment for this action is not required because this action is categorically excluded under 10 CFR 51.22(c).
