On November 16, 2023, the U.S. Nuclear Regulatory Commission (NRC) completed the on-site portion of a reactive inspection at Millstone Power Station, Units 2 and 3, and debriefed the preliminary results of the inspection with Michael O'Connor, Site Vice President, and other members of your staff. On January 10, 2024, the NRC completed its special inspection and discussed the results of this inspection with Michael O'Connor and other members of your staff. The results of this inspection are documented in the enclosed report.

The inspection commenced on November 15, 2023, in accordance with NRC Management Directive 8.3, "NRC Incident Investigation Program," and Inspection Manual Chapter (IMC) 0309, "Reactive Inspection Decision Basis for Reactors," based on the initial risk and deterministic criteria evaluation made by the NRC on November 13, 2023.

The special inspection reviewed the circumstances surrounding an event that occurred on November 8, 2023, and examined activities conducted under your licenses as they relate to safety, security, and compliance with the Commission's rules and regulations, and with the conditions of your licenses.

The enclosed report documents one issue of concern which warrants further review to determine the nature and characterization of any associated regulatory deficiencies. All deficiencies were promptly corrected or compensated for, and the plant was in compliance with applicable physical protection and security requirements within the scope of this inspection shortly after identification. The issue is described in the enclosed report.
