Dear Deborah Weymouth:

This refers to your license amendment request dated June 8, 2023. Please find enclosed Amendment No. 31 which adds Anoop Chacko Achanaril, MBBS, Adriana Dager, M.D., and Indu Doddamane, M.D. as authorized users of 10 CFR 35.100 and 10 CFR 35.200 materials, and removes Thomas H. Farquhar, M.D., Ph.D.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14) and (25). The NRC has determined that these categorical exclusions apply because this is a license amendment pursuant to 10 CFR Part 35 authorizing medical activity and because it involves no significant increase in the amounts, and no significant change in the types, of any effluents that may be released offsite; that there is no significant increase in individual or cumulative public or occupational radiation exposure; that there is no construction impact; there is no significant increase in the potential for or consequences from a radiological accident; and the exemption sought involves education, training, experience, qualification, requalification or other employment suitability requirements.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action(s) against you. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy.
