This refers to your license amendment request dated August 15, 2023, as clarified by the letter dated October 5, 2023. Please find enclosed Amendment No. 32 authorizing increases in the types and/or quantities of materials; revision of the list of authorized users; and change in meeting frequency of the review of the radiation safety program. In addition, you provided an updated list of persons authorized to sign license amendments as management representatives, and informed us that David Pellicciarini is now the Corporate Radiation Safety Officer.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
