Dear Dr. Bridges:

Enclosed is Amendment No. 63 to your U.S. Nuclear Regulatory Commission (NRC) Materials License No. 24-18287-01 in accordance with your request dated November 6, 2023. Specifically, you requested changes for authorized users listed in the license. Your request is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML23310A109 (non-public).

Please note that, we did not add the use of licensed material as permitted under 10 CFR 35.396 for Albert Yang, M.D. To support the request, you stated that Albert Yang, M.D. is board certified and provided a copy of the certificate issued by the American Board of Radiology for Diagnostic Radiology. 10 CFR 35.396(a)(3) states that the proposed authorized user must be certified by a medical specialty board whose certification process has been recognized by the NRC or an Agreement State under § 35.490 or § 35.690. Dr. Yang's certification does not meet the NRC requirement. For your reference, the board certifications which are accepted by the NRC under 10 CFR 35.490 or 35.690 are listed on the NRC's web site at <https://www.nrc.gov/materials/miau/med-use-toolkit/spec-board-cert.html>.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III office at (630) 829-9887 so that we may provide appropriate corrections and answers.

An environmental assessment for this action is not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (CFR) Section 51.22(c).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with
