PART I.D -- COMMENTS

Upon receipt of this request (and several other requests concurrently submitted), we reached out to you to seek clarification of the records you were looking for. With respect to this particular request, you stated that, in the extensive research you have already done, you did not find any major report or guidance that discusses climate change. So, you are seeking records that reflect any deliberations on why the post-Fukushima guidance did not address climate change (you noted that the guidance was limited to discussions of seismic and flooding risks).

Upon receiving your request and clarification, we tasked the Office of Nuclear Reactor Regulation (NRR) and the Advisory Committee on Reactor Safeguards (ACRS) to search for any responsive records. NRR and ACRS staff did not locate any responsive records.
