In accordance with the provisions of 10 CFR 50.54, "Conditions of licenses," paragraph (p)(2), Kewaunee Solutions (KS) is submitting changes to the Kewaunee Power Station Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan, Revision 6 (the Plan) as the enclosure to this letter. The Revision Summary of the Plan provided in the enclosure describes each change. Changes to this document were implemented on February 1, 2024. In accordance with 10 CFR 50.54(p)(2) KS is submitting these changes within two months of implementation.

KS has concluded that the changes do not decrease the safeguards effectiveness of the Plan.

The enclosure contains Safeguards Information. It is therefore requested that this information be withheld from public disclosure in accordance with 10 CFR 2.390, "Public Inspections, exemptions, requests for withholding," paragraph (d)(1), and 10 CFR 73.22, "Protection of Safeguards Information: Specific Requirements," paragraph (a)(4).
